

CALL FOR PAPERS N° 04/2018 REDE UNIDA — SAÚDE EM REDES JOURNAL THEMATIC SUPPLEMENT "CARE WITHOUT BORDERS"

REDE UNIDA Brazilian Association, in cooperation with the entities and organizations named below, makes public this call for papers in order to compose the Saúde em Redes journal Thematic Supplement with the theme "**Care without borders**". This is a joint call with Saúde e Diversidade Journal, publication of the Health Sciences Center at Federal University of Roraima. The papers can be structured as free narratives, theoretical and empirical essays, research reports, related experiences of public policies and social movements' initiatives, among others. Submission guidelines are on the website of Saúde em Redes journal (<http://revista.redeunida.org.br/ojs/index.php/rede-unida>) and it will be accepted papers in Portuguese, English, Spanish, Italian and French.

This call for papers is an articulated initiative between REDE UNIDA; Saúde e Diversidade Journal, (publication of the Health Sciences Center at Federal University of Roraima); Health Sciences Post-Graduation Program, Federal University of Roraima; Laboratory of History, Public Policies and Health in the Amazon (LAHPSA/Fiocruz Manaus); Federal Institute of Education, Science and Technology of Acre (IFAC); International Network of Policies and Practices for Education and Collective Health (Rede Interstício/DGP CNPq); International Health and Cooperation Research Group (UFMT/DGP CNPq); Borders Interdisciplinary Studies Group (GEIFron/CCH/UFRR/DGP CNPq); Primary Care Department, Brazilian Ministry of Health (DAB/MS, Brasil); Health Education Development Department, Brazilian Ministry of Education (DDES/MEC); Center for Studies and Research in International and Intercultural Health, Bologna University (CSI/UNIBO, Itália); Medical Anthropology Department, Rovira i Virgili University (URV, Tarragona, Espanha); Italo-Brazilian Laboratory of Education, Research and Practices in Collective Health, involving several Brazilian and Italian universities; and the Pan American Health Organization (PAHO).

THE OBJECT OF THIS CALL

"Care Without Borders" thematic supplement aims to publicize narrative productions of authors and organizations, results of theoretical or empirical researches, with reports of experience, tests and / or analysis of intervention projects in this thematic area, considering its magnitude, its degree of visibility and its relevance.

"Care without borders" will include papers about: immigration from the perspective of immigrants; refugees and border populations; care itineraries in immigration and refugee situations; intersectoral care practices for immigrants; interculturality, ethnicity and diverse culture approaches in health networks organization; horizontality in class, race / ethnicity and gender relations in taking care of immigrants and refugees; organization of immigrant access to health services: barriers, techno-assistance arrangements and configuration of services; organization of health care networks in border regions; experiences and initiatives to welcome immigrants and refugees; migratory and political phenomena of life; migration flows of indigenous communities and national social protection systems; commuting flows and cross-border flows; immigration and national social protection systems; living networks of immigrant care; humanitarian disasters related to immigration and government and civil society responses; perspectives of international cooperation in the transcultural organization of health systems and

services, globalization of health and decolonization of care; initiatives of international solidarity organizations in health; globalization, modes of production and migration flows; and migration processes and health surveillance.

The analysis should have a inter-sectorial, interprofessional and interdisciplinary scope, and be transversal to the knowledge major areas of health, human and social sciences, privileging collective health field of study. The texts should be elaborated dialoging with visibility production to the experiences lived by the immigrants and other actors implicated in reception and monitoring cross-border migratory flows and immigrants' health care.

SUBMISSION REQUIREMENTS AND PROCEDURES

The texts to be submitted to this Thematic Supplement of Revista Saúde em Redes journal (“Care without borders”) must comply with the conditions of this public notice and satisfy the rules of Saúde em Redes journal submission guidelines. In the submission process, the authors should registry in the initial part of the paper, before the title, the information "**Care without borders Supplement**".

The submission period for any work regarding this call for papers is from **August 15 to October 29, 2018**. If eventually the received papers exceed the volume provided for the Supplement, those approved additionally may be incorporated in next regular numbers of Saude em Redes journal, Health and Diversity journal as well in other thematic collections of Rede UNIDA.

According to Rede UNIDA editorial policy, publications will not be part of any type of commercialization or enrichment, likewise the participants' shall have full responsibility about their personal work production, thus they will be committed to not characterize any unlawful feature, including plagiarism, considering the Brazilian Law No. 9.610 / 1998 or any other determination of civil or criminal nature that applies. Where applicable, the presented analyzes shall comply with the research ethics requirements, in accordance with current legislation.
